The public award ceremony is taking place on **11th of March 2010 at 3.00 pm** at the ITB-Cinema. The presenter will award the Golden, Silver and Bronze City Gate. The best film of all categories will be awarded with the DIAMANT AWARD.

The presenter reserves the right to classify submitted films into another category if required and it improves the chance to get an award.

The award recipient will be informed after the jury meeting. The presence of the participants during the award ceremony in the ITB-Cinema is desired.
